In East Volusia County, the size and scope of projects already underway are nothing short of breathtaking.

As for Team Volusia EDC results, read on. We exceeded our three-year goal in all three critical categories: capital investment, new jobs and payroll. Many advances were made in our work with key organizations. Strong relationships were developed, which will help us continue to compete against other communities throughout Florida and across the nation.

Team Volusia EDC continues to raise the visibility of Volusia County throughout the world through a variety of outreach activities and innovative digital marketing strategies, including the launch of a new website, social media and email marketing. New 2018 Projects

Each year, Team Volusia EDC works directly with prospective companies and/or site selectors interested in the Greater Daytona Region as a location for expansion or relocation. Prospective companies that have been identified as a good fit for Volusia County comprise our "pipeline". The pipeline includes dozens of such companies classified as Stage 1 prospects. Vetting and negotiation refine the list of Stage 1 prospects to a few Stage 5, or prospects that have made a commitment to Volusia County. In 2018, three such companies became Stage 5 prospects. Each has committed to – or has already commenced – operations in Volusia County. They include:





Lucky's Supermarkets

Lucky's is an iconic brand in the fiercely competitive supermarket arena. We have been working with this prospect since 2016. It will occupy the Ormond Beach site of the former Food Lion store. Capital investment is \$10 million, with an annual payroll of \$2.5 million. Lucky's will bring 100 new jobs to the community with an average annual wage of \$25,000.

Forte Frozen Foods

Due to the amazing growth taking place throughout the area, Forte Frozen Foods began exploring a new location in Volusia County in early 2018 and ultimately chose a site in Ormond Beach. Initial investment plans call for 15 new jobs and \$540,000 in payroll to the area with \$600,000 in capital investment.

TechFit Digital Surgery

We worked in concert with the Daytona Regional Chamber of Commerce in recruiting TechFit to Volusia County. It is a Colombian company engaged in the design of leading edge medical devices and techniques. The company has commenced operations at two locations: Embry-Riddle Aeronautical University's MicaPlex and the Volusia County UCF Incubator. Initial employment calls for 15 new jobs with an average annual wage of \$60,000 and a payroll of \$900,000. Capital investment is \$1.5 million. This project has already led to a successful inbound familiarization visit by Colombian officials to Volusia County.
